



Welcome to Triumph Treatment Services (Triumph)! We understand that navigating food benefits while in treatment can be overwhelming, and we are here to make it as simple and straightforward as possible. This document is designed to answer most of your questions about how your benefits are managed during your time with us.

In this document, you will find clear explanations about Triumph's partnership with the Supplemental Nutrition Assistance Program (SNAP), how your food benefits are calculated, what happens if you have family members on your account, and how to handle situations like a lost electronic benefit transfer (EBT) card. Our goal is to ensure you feel informed and supported every step of the way.

Overview:

Triumph is authorized through the Food and Nutrition Services to serve as an authorized representative for SNAP (7 CFR 273.11 (e) & WAC 388-460-0010). This allows residents in treatment to continue to receive benefits (WAC 388-408-0040). Under WAC 388-460-0010 the Financial Specialist is your authorized representative while at Triumph.

Program:

The Financial Specialist will submit a change of circumstances to DSHS, notifying them of your participation in treatment. Triumph will calculate the amount of benefits owed as follows:

Awarded Benefits	Daily benefits (30/31)	14 nights	20 nights	30/31 nights
\$292	\$9.73/\$9.42	\$136.22/\$131.88	\$194.60/\$188.40	\$292/\$292

- The above is only an example; individual awards will vary.
- If you transition out of the program prior to the planned completion date, funds will be refunded to your account

If other family members receive benefits through you, only those in our facilities will be included in the calculation.
